Bath Twp. considering smoke-free parks

BATH TWP. — Bath Township parks may become smoke-free, if board members decide to act on a recommendation from the township's parks and recreation committee.

Members heard a presentation at their July 16 meeting on the recommendation, which calls for prohibiting tobacco anywhere in the township parks, a step that goes beyond other communities which have designated certain areas, playgrounds and beaches, for instance, smoke-free.

Ingham County parks have smoke-free play areas, beaches and concession areas. Smoking is also prohibited on the splash pad at Hawk Island Park.

Eaton County passed a resolution last May discouraging smoking in its parks and prohibiting it in specific spots: playgrounds, athletic fields, beaches, aquatic areas, restrooms, spectator and concession areas and all enclosed structures.

A recommendation to design-
